

Castrol Activ Scooter Contest Terms & Conditions

1. This Castrol Activ Scooter contest (“Activity”) will be governed by the Terms and Conditions (“T&C”) contained herein below. The Participant agrees that he/she has read and understood the T&C by participating in the Activity and each Participant agrees to be bound by the T&C.
